

## LIMITED LIFETIME WARRANTY POLICY ON WORLDPARTS\* BRANDED PREMIUM COATED BRAKE ROTORS (WPS-606) AND BRAKE PADS (WPF-608)

## **Limited Lifetime Warranty**

Uni-Select Purchases G.P. ("Uni-Select") warrants all specific products listed above (the "Products") to the original purchaser against defects in materials or workmanship when used on private passenger cars and light trucks under normal operating conditions as long as the original purchaser owns the vehicle on which these Products were originally installed per application listed in the catalog. This limited lifetime warranty does not apply to (i) the anti-rust protective coating on the Premium Coated Brake Rotors (WPS-606) or rust<sup>1</sup>, (ii) accidents, alterations, negligence, misuse, wrong application or incorrect installation which results in or contributes to Product failure; or (iii) Products installed on commercial, fleet, racing, off road, marine, or industrial motor vehicles. No Uni-Select distributor or any other retailer or installer may make any warranties on behalf of Uni-Select with respect to any Worldparts Products to any consumer or customer to which it sells Worldparts Products. This limited lifetime warranty is non-transferrable.

Uni-Select's sole obligation under the warranty is limited to the replacement or credit for the purchase price of the non-conforming Product, at Uni-Select's sole option. Cost of removal, installation, towing, replacement rental, storage, and repairs are not covered, nor are the cost of shipping and freight to return Products to Uni-Select. Replacement Products are individually warranted only under the same terms and for the remaining balance of the limited warranty period applicable to the replaced Products.

Uni-Select reserves the right not to replace the Products or credit the purchase price of the Product if the Uni-Select distributor fails to obtain the proper authorization or submit the necessary documentation. THE STATUTE OF LIMITATIONS APPLICABLE TO ALL CLAIMS ARISING UNDER THIS WARRANTY OR OTHERWISE SHALL BE ONE (1) YEAR FROM THE DATE THE CLAIM FIRST ACCRUES.
